- V. **AGENDA APPROVAL-** Motion to modify the amended agenda made by Council member Linda Pilgrim, seconded by Council member Erica Miles, motion carried.
- VI. OLD BUSINESS-
  - 1. Budget Public Hearing

- a. Employee Salaries/ Raises/ Benefits Much discussion was had on the budget and some recommendations were made for a few changes that are in the budget.
- 2. **Sewer Upgrade** Jim Sunta- Spoke about how to proceed with the renewal or modification of the existing land application system permit, That is pending whether or not you are making a decision to go with the current design or upgrade the plant as designed or if you are going to select an option to incorporate what the options that we presented into that. If you do want to do that then we would have to resubmit a design as well as a design report to EPD and have their approvals on that. So, we would just need to go ahead and renew the existing permit just for the 50,000 right now and submit a request to modify it later. If you elect to go ahead and bid on the project that is set right now then we can go ahead and modify the permit up to 100,000 gallons per day. All agreed to stick with the plan that they had already created.
  - 3. **Zoning Map** Mayor Moore discussed the newly drafted zoning map and the changes that have occurred since 2017.
  - 4. **Downtown Development Authority Appointment-** Council Member Erica Miles nominated Joel Henderson of Henderson Painting.
  - 5. **Code of Ethics Ordinance-Tony Powell** mentioned there were two forms in your notebooks and they recommended the one from the GMA. All council agreed with the GMA form.
  - 6. **Council Reimbursement-Council Member Moncrief** If I go to A Chamber Council Meeting or any other meeting can I get reimbursed for that, Yes just ask if they have a billing option and have them to bill us.

- VII. 1. New Business Case #RZ-18-03 P & Z Joe Walter Held discussion and answered questions about the new Gas Station and the exterior @ 1091 Hwy 138.

- 2. P & Z Commissioner Joe Walter- Bed and Breakfast It has considered amending the zoning ordinance to make a couple of changes to the table of uses to article 9 of your document. Pacifically to address the fact that the existing currently as it is presented a Bed and Breakfast Inn is permitted in some areas but not in others, The one in question is in AG district. The proposal would be to make a couple of text amendments to article 9 specifically to under the table of uses under Bed and Breakfast Inn to go ahead and allow it as permitted use in the AG district. And it is listed as a conditional use in the R3 district and under the proposal it would to be removed as a conditional use in R3.
