IX. Library Report- Dana Seger- I had a wonderful opportunity on Monday to help at Reading Camp at Walnut Grove Elementary School. The students, teachers, assistant principals, and Principal were wonderful to work with. I was even able to give out information to parents at the carpool drop off to get their children signed up for our Summer Reading Program. Each class I worked with from rising 1st graders to rising 4th graders were able to pick their favorite book to read together. The students were very excited to hear about our programs we have daily and weekly at the library.

We have already given away dozens of new books to children who have read at least 10 books this summer so far. This week's summer performer is the Ken Scott Magic Show. The magic show is tomorrow at 3:30. Next Friday, we have the Jason Clark Reptile Show and our new performer is the Exotic Animal Encounter through Iron P Homestead, which will be out to visit us in July. As a reminder we often get over 100 visitors for these performances, so be sure to plan to arrive early. But we activities planned all throughout the week, including a Father's Day Card craft event on Thursday. June 15<sup>th</sup> from 3-5.

We also have had amazing attendance for our weekly story and craft time with Miss Moore and often have between 40-60 patrons visit us. Also, our puzzle table continues to be a huge hit with patrons, and they often come completing a new puzzle each week. At the request of some parents and children, we are starting a brand-new program called Pokemon Swap so that our young friends can swap Pokemon cards and meet new friends. - Public Comments- I am Andrea Gray my office address is 300 E. Χ. Church Street, Monroe GA, tonight I am hearing representing Reliant Homes and I know I sent you all a letter yesterday I am sure you have had a chance to read it so I want read you everything in it. But just in this short time I have for a public comment I did want to express my client's frustration with a lack of due process. In processing its application for a sewer variance under ordinance # 2021-09 for the ordinance all that is required is for the applicant to file an application and then city council takes a vote. It is not a zoning matter and does not require a planning commission. We are not trying to amend any ordinances; my client was a good sport and tried to work through the process the best that we could. But it seems one roadblock after the other keeps being thrown up in front of us and causing a significant delay which is increasing the cost of our project. And so, we inform the city to act to due process in this matter I think not adding it to the agenda tonight is going to make some decisions we did not want to make we wanted to work with the city on this. My client had actually met the requirements of the ordinance which is that we did file an application for a sewer variance that is zoned an R1 on our 171 acres. We showed in our application that there is not adequate sewer capacity to serve our full development, we showed that our project will support a sewer system, we've got two soil surveys from the health department and a letter demonstrating that we show that our clients will suffer a hardship if the variance is not granted figuring that there would be a great delay waiting for the city to upgrade there current sewer

capacity. And given that a sewer pump station would be required because of the grade of the property which would make it very expensive unless we ask for this variance.

Kerry Brown- 1400 Olympic Ct. Oxford, GA - Is there a reason why you have not addressed the variance. I would like them not to force them to have to connect to the sewer. If you force them to go onto the sewer you are going to increase the population density behind my house. Which is in turn going to increase the traffic on the roads around here, it is going to increase everything around here and I don't think that the City of Walnut Grove is ready for that at this moment in time.

#### XI. OLD BUSINESS-

- Rezoning Application for Forest Glen- Mayor Moore made a recommendation to remove the Zoning Application off the agenda for Forest Glen. Council Member Moncrief made a motion to remove Forest Glen off the agenda, seconded by Council Member Erica Miles, 2 voted to pass 1 opposed.

Council Member Moncrief asks would this be a time to bring up as issue that I see in Emerald Cove that might affect the city. People are starting to put in cement, I noticed today they are tired of waiting.

It has to run three times before action is taken. So, it will be on the July 13<sup>th</sup> meeting, it will run the last two weeks of June and the first week

- of July. **Council Member Moncrief-** Is that being done, I am sending this to Clerk.

# CITY OF WALNUT GROVE PLANNING COMMISSION REPORT TO MAYOR AND CITY COUNCIL JUNE 8, 2023

Good evening! I will try to be brief!

At its meeting of May 18, the Commission after a public hearing tabled the matter involving the rezoning application of the property a 1071 Walnut Grove Parkway, Paul & Toby Jones, Owners and Kippy Clark, Applicant, pending a more detailed traffic study and an opportunity to future investigate several aspects of their request. We will be taking that up that case again at our meeting next week, June 15, 2013.

At your work session on 5/25/23, there was some discussion regarding how Hall Consulting expected to fold the effort they are proposing with the proposed Town City Plan developed by Northeast Georgia Regional Commission. I contacted Marilyn Hall for clarification and learned that their proposal is in fact predicated on a Town Center Plan being in place. Marilyn also advised that they could with some tweaking merge the two together. She shared that she is out of town until next week, but if the city desired, they would be willing to augment their proposal to indicate how they would merge the two efforts.
